
Dugong Conservation & Management Status






Aim: Improve the conservation & management status for Dugong population in PNG





COMMON THREATS TO THE SPECIES

- Over Hunting/Overfishing
- Frequently caught to sell/Income
- Commercial Demand
- Over harvesting of turtle eggs
- Continuous use of nets on reefs
- Destruction of sea bed by Pollution (e.g Mining)
- Accidental Netting (Unintentionally Caught).
- Dynamite Fishing
- Use of Poisonous Roots (Western, Kimbe)
- Increase in human demand/population in the provinces has put a strain on the marine resources
- Land based pollution especially from the logging, agriculture and mining activities has affected the overall marine ecosystem in one way or another.


