Consist of 2 output

- Water policy revised to incorporate climate change risk and resilience aspects
- Development of National Climate Change Policy











Water policy - revised to incorporate climate change risk and resilience aspects

- PACC work in collaboration with IWRM –avoid duplication of work in terms of Fund & Resources
 - PACC done the initial work:
 - Recruit a Local consultant literature review on water & to identify gaps that still need to address and to incorporate CC in to the policy. (Complete)
 - IWRM have recruit a Local Consultant to work on the policy and PACC will assist IWRM.











Development of the National Climate Change Policy

- PACC initiate this activity, and now work in collaboration with Dept of Env and relevant stakeholder.
- Process has been started
 - Phase 1 May (experts from SPC-SOPAC, SPREP & UNDP visit Tuvalu – assist Tuvalu in developing its NCCP)
 - Phase 2 July (country team visit outerislands & continue with 8 island community on Funafuti as of to date collect data & information)
 - Phase 3 October (target the Kakega II Review so that CC can mainstream in to the national strategy plan).
 - Final document is target to be ready around early Nov before the parliament session.











Project Management

- PACC Project is under the Ministry of Public Utilities and implemented under the Dept of Works.

 - PACC prepare a Quarterly Newsletter targeting NGO's, all Government depts. & schools.
 - PACC also work closely with media in advocating the importance of water.
