It is reporting time again! Below are some specific requests for you to reflect on and respond accordingly.

Annual Work Plan (AWP) 2010

As part of the PACC Technical Meeting in October, we started the development of the 2010 Annual Work Plan. Hopefully, you would have completed that work by now. It is therefore my humble request if you can submit that to me by the end of next week (11th December, 09). This will enable me to review the AWPs and revert to you my comments prior to forwarding it to UNDP for their internal review.

It is important that this timeline is adhered to so that subsequent processes such as approval through the SPREP and UNDP systems and the meeting of the Project Executive Group (PEG) is made within the December time frame or early January to ensure that the AWP for 2010 is approved and funds made available for implementation.

Your Work Plan for 2010 should be in line with the milestones outlined below that we discussed and agreed at the Technical Workshop (USP, Suva).

- PACC COMMUNITY CORE TEAM(OPERATIONAL)
- PACC COMMUNITY COMMUNICATION STRATEGY (DEVELOPED AND OPERATION)
- PACC ANNUAL REVIEW MEETING(COMPLETED)
- V&A ASSESSMENT (COMPLETED)
- SOCIOECONOMIC ASSESSMENT(COMPLETED)
- ADAPTATION OPTION IDENTIFIED, ASSESSED AND COSTED
- INITIAL POLICY REVIEW
- DRAFT DEMONSTRATION GUIDE (DEVELOPED)
